

## Going forward after Marseille 2022

- Hold hybrid working sessions to clarify TOC, objectives and scope (some authors in person and some remote virtual) July – September 2022
- Assigned authors develop first Draft Bulletins during period October to December 2022 with periodic Zoom Review meetings
- Review first draft for conformity with Bulletins 1 and 2 and consistency within B3 and proposed edits as necessary – January – February 2023
- Circulate first DRAFT to Committee H members, March/ April 2023
- Review Draft at Committee Meeting in ICOLD Gothenburg June 2023
- Editing of draft according to agreements in Gothenburg August to October 2023 with periodic zoom review meetings
- Circulate revised DRAFT to Committee H members, December 2023
- Receive comments and edit final draft as necessary January/February 2024
- Submit Bulletin for ICOLD New Delhi GA Approval in March 2024
